1. The subscription of the 2022 FIFA World Cup Qatar™ channel pass for public viewing event (“World Cup Channel Pass”) is available for purchase by Commercial Establishments (“CEs”) which intend to host a viewing event of the 2022 FIFA World Cup Qatar™. Please refer to our rate-card for pricing.
2. The abovesaid subscription package includes one (1) decoder and one (1) outdoor dish unit of CE Post-paid Viewing Event account.
3. The basic setup installation of decoder and outdoor dish unit will be borne by Astro, however if there is any additional setup, extra charges will be borne separately by the CEs.
4. A standard length of 15 meters’ cable is budgeted for the abovesaid basic setup, any additional length of cable would be charged separately.
5. This account is strictly to be used only for the viewing event of 2022 FIFA World Cup Qatar™, after the 2022 FIFA World Cup Qatar™, the account will be terminated and dismantle.
6. All prices are inclusive of SST.
7. Astro maintain the right to change the pricing and packages without any prior notice.
8. Astro shall not be held liable for any cancellation, delay or change in the scheduling of any match at the advertised time or the appearance of any team(s) or player(s) in any match as advertised. Astro may also vary its services or any part thereof at any time by changing or withdrawing a scheduled match, adding another match, or changing the transmission time of a scheduled match. Astro will provide its customers with as much notice as possible of such changes. Astro will not be liable for any loss or disappointment as a result of these actions.
9. Astro reserves the right to cancel, disqualify, refuse, or reject any application to purchase /subscribe to the 2022 FIFA World Cup Qatar™ and/or not continue with this Special Campaign at any point in time without assigning any reason. In such a situation, if the Customer has paid for the World Cup Channel Pass, Astro’s sole liability to the Customer would be to refund the monies paid by the Customer for the World Cup Channel Pass.
